#### Edward L. Boyce, III

I was born in Richmond, Virginia and grew up in Bon Air, Virginia, a suburb of Richmond. God called me, while still in my mother's womb, to be a disciple of Jesus. According to God's gracious providence, I was born into a Christian family. My parents saw to it that all five of their children grew in the faith and attended church. My entire family was active in the church and when the doors were opened, we were there. Throughout my youth, I was active in Sunday School, Youth Group, and the choir.

Upon graduation from High School, I attended Emory & Henry College for two years. During that time, I first sensed God's call upon my life to enter full time Christian ministry. I decided to spend some time working fulltime, hoping this would clarify God's call.

I was a sales representative in the bearing and industrial supply industry for several years before returning to college fulltime. It was at this point that I acknowledged God's call and responded with my willingness to enter fulltime pastoral ministry. I graduated from Virginia Commonwealth University with a degree in History and Religious Studies

I attended Union Theological Seminary in Virginia where I earned a Master of Divinity. While attending seminary, I met and married my wife, Rev. Marian J. Carmical. Following my graduation and preceding my wife's graduation, I worked for Union Seminary fulltime for two years.

My wife and I accepted a call as co-pastors to a three-church parish in Henderson, NC. (St. Andrews, Brookston, and Young Memorial Presbyterian Churches) While in Henderson, our son, William was born. We enjoyed ministry surrounded by fields of tobacco, soybean, and corn.

Following our ministry in Henderson, I accepted a call to First Presbyterian Church in Winnfield, Louisiana. While pastoring in Winnfield, I worked with the local congregation and with the presbytery on Redevelopment and Revitalization issues and strategies. I spent the majority of my continuing education time studying and learning about congregational redevelopment and revitalization. While in Louisiana, I was actively involved in Kairos Prison Ministry, Rotary Club International, and the Winn Parish Literacy Council.

Sensing God's continued call in my life, we moved to Franklin, Virginia to working with another congregation in Redevelopment and Revitalization. In Franklin, I continued to work with congregations on redevelopment and revitalization issues as well as helping other congregations with developing and implementing effective stewardship ministries.

My next call was to the Eureka Church in Whispering Pines, NC. We lived in Whispering Pines for almost nine years. During my time there I enjoyed helping the congregation reconnect with the community around the church. We especially concentrated on strengthening the relationship between the congregation and the elementary school next to the church's property.

I currently serve as the Transitional Pastor and Head of Staff at First Presbyterian Church of Statesville, NC. I have worked extensively with the Transition Team, Mission Study Team, Session, and congregation in preparation for collecting data for the Mission Study, assisted in writing the Mission Study Report, and been a resource for the PNC. It has been my pleasure to serve this vital and historic congregation in their search for a new called and installed pastor.

In my spare time, I enjoy playing guitars, building guitars, spending time with my wife and son, swimming, cooking, photography, reading spy novels, and playing and watching any sporting event.

#### Statement of Faith Edward L. Boyce, III

I believe in God the Father Almighty, who created the universe and continues to sustain and rule the universe. While being one in substance, God is distinct in three persons: God the Father, the Son, and the Holy Spirit. Humankind was created in God's image. God calls humanity into covenant. God continues to sustain the covenant relationship with humanity and calls women, men, and children to follow him, glorifying and enjoying him forever.

Jesus Christ is God's only begotten son. God sent Jesus to rescue us from sin. Jesus came to restore humanity to fellowship with God. Jesus accomplished for us that which we cannot do for ourselves by reconciling us with God. He accomplished this through his life, death on the cross, and his resurrection from the dead. God raised Jesus from the dead and Christ Jesus sits at the right hand of God. To Christ belongs the victory. Come, Lord, Jesus Come!

The Holy Spirit teaches, comforts, edifies, equips, and guides humanity. The Holy Spirit renews us in the image of God and enables humankind to die to sin and live in righteousness. The Holy Spirit guided the production of the Scriptures and opens them to us today as both the unique and authoritative witness to Jesus Christ and the rule of the faith and life of the church. The Holy Spirit gathers us into the church and leads us forth in mission into the world. The Holy Spirit communicates to us the grace of God, the forgiveness of sin, and the gift of faith. By the Holy Spirit, we are endowed with spiritual gifts, the call to obedience and service, and eternal life.

I believe that the sacraments are signs and seals of God's covenant with humanity. I believe that the sacraments are an outward and visible sign of a spiritual and an inward grace. Through baptism humanity dies to that which separates us from God and will be born into new life in Jesus Christ. We also receive the promise of new life in Christ and the hope of the resurrection.

The waters of baptism cleanse, renew, purify, and restore humanity. Baptism points back to God's grace and forward to God's promises. I believe that the Church is the Body of Christ and is God's earthly demonstration of what is intended for all humanity. Through the Church, God proclaims the gospel to the world. She enacts signs of repentance, forgiveness, reconciliation, and new life for humanity. God calls all of the disciples of Jesus to be disciple-making disciples, to invite people into relationship with Jesus, to be equipped for ministry, and to go into the world to minister in Jesus' name.

#### My Spiritual Journey: John H. "Jack" Haberer, Jr. April. 21, 2020

Born in Queens, N.Y., and raised in northern New Jersey, I was baptized and confirmed into the Roman Catholic faith. However, as a typical adolescent of the day, I lost faith in God and church as a 14-year old. I called myself an atheist. However, as a budding musician, I enjoyed the music of a rock band in a high school assembly, so I went to hear them perform in an evening concert. There they sang songs that sounded strangely religious. I was intrigued. I went to a "follow-up meeting" at a small church and planted my bluejeaned self on the floor of a fellowship hall with about a hundred other teenagers. They spoke enthusiastically about Jesus. We broke into small groups. My group's leader soon invited me to pray a prayer to accept Jesus into my heart. I didn't get what he was talking about, but I followed his lead and prayed as guided. Immediately, I felt like something changed in my life.

That took place exactly 50 years ago today: April 21, 1970. I count today to be my 50th spiritual birthday.

My faith took off like a rocket. I told everybody I knew about Jesus. In the next year I led about 100 high school classmates into the faith. Just after my 16th birthday, I started a weekly coffeehouse, The Mustard Seed, at the Episcopal Church. I began singing and playing guitar in a duo, "Nick and Jack." Soon the coffeehouse had an average attendance of around 200. The Jesus Movement was upon us.

The Mustard Seed and the Jesus Movement became my major passion through my high school years, and it was in a senior calculus class (I was good in math) that I realized that I didn't want to do this as a career. "I have to be a pastor," I said to myself. That proved to be my call moment. I never looked back.

I enrolled in a Pentecostal Bible college where I learned so much about the Bible. After three semesters I transferred to a Methodist liberal arts college, majoring in Religion and Philosophy. I got captivated with the claim, "All Truth is God's Truth, Wherever it May be Found," and felt called to be a preaching scholar.

Barbie Niswander and I married right after graduation in the Bible college's sanctuary. We moved to my New Jersey hometown, where I worked in a Christian bookstore. We helped turn the Mustard Seed into a non-denominational church. I served on the board and, lacking a pastor, preached about once a month. The church saw fit to sponsor us, along with two babies, to enroll at Gordon-Conwell Theological Seminary. There I was introduced to more classical expressions of Protestant faith. They also turned this Jesus Freak into an adherent of the Reformed faith. They also introduced me to a vision for justice, inclusion, and diversity – for which I later became an outspoken advocate.

Upon graduation I was hired to the staff of New Covenant (United Presbyterian) Church in Pompano Beach, Florida, where I was taken under care to become a Presbyterian pastor. I self-taught the needed understandings in preparation for ordination exams. And, I had another conversion while reading the Book of Order. Yes, it was a religious experience to discover the wisdom and soundness of the applied faith that the Presbyterians had developed over the centuries.

Two years later, I was ordained and called into my first pastorate in Satellite Beach, Florida. The presbytery executive took me under wing to help orient me to the Presbyterian life. Soon I was serving on presbytery committees and getting active in the larger church. I earned a D.Min. degree from Columbia Theological Seminary which broadened my comprehension of the Presbyterian theological and interpersonal culture.

After a wonderful 10 years in Satellite Beach, I was called to Clear Lake Presbyterian Church, in Houston, Texas. A 12 year tenure brought robust ministry opportunities, including service on three General Assembly task forces. I also wrote my first two books, one on the Holy Spirit and the other on denominational conflict.

I was called to serve as Editor-Publisher of The Presbyterian Outlook, and loved my nine years of reporting about and giving my counsel to my colleagues in ministry. Sensing a need to return to the pastorate I served for two years as pastor of Vanderbilt Church in Naples, Florida, and four years as pastor of First Church of Allentown, Pa.

Barbie and I will soon celebrate 44 years of marriage. We are looking forward to the prospect of returning to the Great State of Texas to carry forward the ministry that God may wish us to do, with the added benefit of being nearer to our two children and six grandchildren. Looking back and ahead, we count our time together in service to our Lord in the PC(USA) to be rich in the grace of our Lord Jesus Christ, the love of God and the communion of the Holy Spirit.

#### A Statement of My Faith John H. "Jack" Haberer, Jr. April 21, 2020

I believe in, that is, I depend upon God.

I believe that God is and always has been comprised of three persons, most commonly named Father, Son and Holy Spirit.

I believe in the God of love, introduced in the first words of Scripture as the Creator. Like any artist, God turned imagined beauty into an observable reality by inventing stars and planets. As a being of beauty, God created living organisms on at least one of those planets, earth, and as that God of love, created human beings with whom that love could be shared.

The first humans declared their independence from and rebelled against God. God's existence allowed no such rivalries, so the humans were banished to live their lives estranged from the Godhead. But the loving God did not rest content with that. God sent representatives – emancipators, prophets – to plead the case for reconciliation. #### Life Journey in Faith

I would like to begin this introduction at the Spring of my life, I was born in Mercedes, Texas. I was baptized at First Presbyterian Church of Weslaco and had a fantastic childhood. One younger brother, parents, grandparents, aunts, and uncles who all loved me, and I them. My father was a pilot, so we moved a few times around the state and country. That was an education in and of itself. We were the 'new kids' and learned how to adapt to new settings, while my Mom made a wonderful home for us wherever we landed. I had my first theological debate with my Episcopalian best friend at age six regarding debtors ...... not trespasses in the Lord's Prayer. VBS at First Presbyterian Church of Weslaco are some of the absolute best memories of my first eight years on earth. I was confirmed at age eleven at the First Presbyterian Church in Mineral Wells, Texas and I sang in the Children's Choir there. We finally came back to the Rio Grande Valley, to Harlingen, Texas for my freshman year in high school. I transferred membership to First Presbyterian Church of Harlingen at age fifteen and at seventeen taught my first Kinder Sunday School class.

As the Summer of my life approached in April of 1975, my Jr. year in high school, God placed this beautiful young man across the street from my parents' house. I dropped out my Senior year to marry the love of my life, Rusty Truax, on November 21<sup>st</sup>, 1975. I was eighteen, he was twenty and fresh out of the Army. We were living on love and our faith was strong. We had a paycheck and a car. Our first daughter was stillborn in September of the following year. I miscarried another daughter that was a twin to our third son, but GOD is so good. We were blessed with three living sons and three daughters who range in age from 42 to 24.

Due to a horrendous choice made in 1995 by our oldest seventeen-year-old son, he is serving life in prison. The experience of grace in this situation has been nothing less than holy. Our family is stronger in faith, love, and tolerance because of it. We are so blessed by the man he has become. Through the Kairos ministry he flourishes and helps his fellow prisoners find their way to Jesus.

I homeschooled the rest of them and they have exceeded our hopes and dreams - four college graduates, one farmer/rancher living his dreams and one published author, busy on book #2. I cannot take the credit or the blame for my children. They were gifts surely from above. All were baptized at First Presbyterian Church of Harlingen and three have become Elders. I taught every age level of Sunday School sometimes more than once, participated in all the VBS', Christmas Pageants, and was a guardian/leader in all the youth groups and Mission trips for over thirty years.

The Autumn of my life was full of highs and lows......Such as our oldest daughter, at sixteen-years-old giving us our first grandchild four months before I gave birth to our youngest daughter. Our family continued to grow with in-law children of the heart; three more sons and two more daughters. Yikes eleven adult kids in all! We have also been blessed with three grandsons and eight granddaughters who are all joys and keeps us busy.

Being pronounced dead at 7:03 am, June 26, 2006, after having five massive heart attacks in a row, and flat lining four times I had the front row seat of a miracle....I am alive and well! I can witness that death

is nothing to fear, it is a new beginning. In 2011, my mother became ill and I became her caregiver in our home. After seven years, at ninety-two, momma flew home to her Lord, and we celebrated her long very blessed life with a party.

During the late Autumn in my life, I took more leadership roles at First Presbyterian Church Harlingen. I was ordained a ruling elder and served on several sessions. I was the Chair of different Committee/Teams and participated as a member of them all. While serving as Clerk of Session, we came to the heart wrenching decision to sell the property and transferred to New Hope Presbyterian Church in La Feria, Texas. I now serve as Treasurer and have resigned from the current session as of June 30, 2020. The transition to La Feria has been an amazing blessing, I have no regrets.

Now I enter the Winter of my life. Dedicating this time to the LORD is appropriate. Over all the years He called me, I put Him off first raising children, then caring for my mother. Until I heard Him ask, "Now what's your excuse?" I had none, it was time. Through the mentorship of Pastor Sheri Dittman, I was introduced to Union Presbyterian Seminary in 2017 for their CRE certification program. I was blessed with two years of wonderful training. The professors, other students and classwork were all soul food for me. I learned so much and I would love to do it again.

I have been blessed from birth and OH! how HE continues to bless me! Rusty and I will celebrate forty-five years together this November. Our kids, grandkids and great granddaughter are well and thriving and all faithful followers of Jesus. My weird (Titus 2:14 KJV) little church called New Hope continues to be a work in progress and I am honored to be part of that process. I give all the thanks, praise, and glory to our Almighty LORD.

#### Manjung Tsai Journey of Faith

I grew up in a Christian home. Although I was familiar with Bible stories and basic truths since I was a child, I always felt that the Christian faith belonged to my parents and not to myself. Thus, I gradually left the church during my high school years. It was not until the age of 20 that I began to search for the meaning of life and realized that this God is not only the God of my parents, but also mine. Since my conversion experience, the Holy Spirit has constantly been transforming my life, including my words, actions, values, morals, and attitudes so that I could become his vessel for the rest of my life.

In 1997, I sensed a calling from God. I gave up my job in computer science, entered Holy Light Theological Seminary, and obtained a Master of Divinity in 2001. After five years of studying and serving, I gradually realized that my gifts are in preaching, teaching, and starting ministries.

In July of 2001, I began my first year of full-time ministry. The church that I served at was the Kaohsiung Holiness Church. During the first year, I studied with the Rev. Benjamin Lee, whose gift lies in the exegesis and teaching. I was also greatly influenced by his preaching and leading of Bible studies. Five months later, Pastor Lee immigrated to the United States. For the next year, I was put in charge of the church while the congregation waited for a new pastor. During this time, I had the opportunity to learn how to independently shepherd a traditional church of more than 200 people.

In November of 2002, Rev. Nathan Wu took over the post as the senior pastor. Pastor Wu has considerable gifts and experience in the administrative organization. Also, Mrs. Wu, on the other hand, has the gift of caring for others. In them, I learned the pastor's heart, the persistence to truth and the commitment to ministry.

In 2008, God clearly spoke to me through Hebrews 11:8-9. When I went out, I did not know where to go... It seems to be a different place..." (... And he went out, not knowing where he was going... as in a foreign land...) This was the main reason I chose instead to continue my studies abroad. In May 2008, I entered Logos Evangelical Seminary to pursue Doctor of Ministry. I realized that I experienced the most growth in leadership, especially in church conflict and spiritual authority, as well as my communication with my family.

In September of 2011, I served as the senior pastor of the EFC of South Florida until the end of November of 2018. This was my first time shepherding a small church. There were many things that needed to be done or required participation by the shepherds themselves. Interpersonal relationships were more important than decision-making. God gave me this experience to further equip me in this unexpected area. In 2018, my contract with the church expired. After a period of prayer, I decided not to renew the contract with the church. Amazingly, the second day after I submitted my resignation to the

deacons, a long-lost pastor suddenly called to ask about my current situation. He happened to be charged to find a pastor for ATPC. This coincidence left me with a fond impression toward ATPC. After forty days of prayer, my wife and I felt peace about it. ATPC also felt that we should work together, and so I accepted ATPC's invitation to be their senior pastor.

#### Manjung Tsai Statement of Faith

I believe the Father, the Son, and the Holy Spirit is a trinity in unity, and they are a unity that in triunal. God is creator of all things and the sovereign Lord of the universe who loves this world and all people freely and justly in Jesus Christ. Jesus Christ is both the fullest expression of God and the fullest expression of a human, combining both dimensions in himself in a mysterious way that is completely unique among all who have ever lived. The Holy Spirit breaks into our old ways of life and thinking to bring fresh new ways that give honor and glory to God, and calls brings together, and empowers a community of Christian believers who will worship, love, and serve God by being followers of Jesus Christ.

I believe the holy scripture is the revelation from God, written down by men who are inspired by the Holy Spirit. The scripture reveals the Triune nature of God, the understanding of the church, redemption, and of the world. In teaching truth, the holy scripture is both necessary and has absolute authority.

I believe sin lives in the hearts of men and affects the man's reasoning, emotion, and will. Therefore, man by merit cannot achieve rebirth and salvation. Only through the Spirit's work that allows a man to obtain the faith to receive Christ, towards the renunciation of sin, and for the restoration of identity as son/daughter of God. However, justification is not equivalent with sanctification. Sanctification in an internal process that occurs inside a person. It's a continues growth process, and would not end in this lifetime.

I believe that church is a community formed by those who place their faith in Christ, and those who seek sanctification. The communion of saints is the essence of church. Christ is the head of the church; Christ unites the saints with Himself through the work of the Holy Spirit, making them members of His body. The relationship between the three are: "preach the truth yet do not become reliant on the sacrament; honor the sacrament while clinging to the truth; enact disciplines to ensure the pureness of the truth, and the holiness of the sacrament"

#### Dr. Brian Wiggins Journey Of Faith And Ministry

Nearing the start of my college days I began a prayer that lasted for years! Three of my high school buddies were ready to head to college knowing exactly what they wanted to study and what they "wanted to be when they grew up." I didn't! I didn't have a clue as to what I wanted to do vocationally. Having been raised in the Presbyterian Church in a family that always participated in the life of the church, I not only believed in God, but knew that God had me here for a purpose. The question that plagued me was how my vocation would fit in with that purpose. As a child and a teen, prayer had been a part of my life. Also, knowing Jesus was with me, I began praying, "Lord show me which way to go. Please show me what you would have me do as a career." Little did know where that would take me.

I felt a partial answer while in college. I enrolled in premed courses and through an elective I took a business class. I enjoyed the business class much more than memorizing scientific names of worms and bacteria, so I took it as a sign from God to declare business administration as my major. Although I still did not know which area of business or the line of work I would spend my life doing, I saw this as God's leading. Encouraged somewhat, I continued my prayer as I declared my major of study.

I graduated college with my bachelors of business administration in hand and was fortunately hired by a commercial finance corporation in Dallas. Although my job seemed to be a good step in the direction of finding the answer to the prayer I had started years ago, I did not have a complete sense of peace. So, I continued praying God would show me what I could be passionate about doing.

A tragedy in my life helped shape the answer to my vocational prayer. While living in Dallas with my older brother, he was tragically involved in a fatal auto accident. His sudden departure from this life into heaven put me in greater touch with all I had come to believe. I always knew there was a heaven, but heaven was no longer some blissful place I would someday enter, it was very near. I knew my life was directed toward Jesus and he would lead me into God's eternal presence, but it was a very real presence that lead me through my grief. Although my faith always meant everything to me, it meant even more after I buried my brother and emerged with a greater sense of how important it is to live for the Lord while we are here in this world.

My career took me to Atlanta. Although I was thankful for God's provision, I continued to have an angst about my vocation. Like my high school friends, I desired to have the firm sense of calling they seemed to discover. While my prayer continued, I found myself driving home from church imagining what it would be like to be a minister. Even though these ideas became frequent musings, I wrote them off to imagination. I did not believe I had the talent or skill to be a minister.

While working in Atlanta, a client from work offered me a position in sales as they believed I showed promise in establishing relationships with customers. I thought this was the answer to my prayer started long ago! I accepted the job offer and moved to work in California. I did enjoy the new position much more than my former one. The angst I had for years, the vocational question I had asked for a long time, appeared to have been answered.

One day in church, after working my new job for three years, a missionary preached. The sermon was on the Great Commission. I was truly moved by the sense of call God had on our lives. In my relationships built with customers at work, I was surprised by how many of them stated they had no faith or very little spiritual practice. After worship, I went to the beach needing to pray. I asked, "God am I in the right vocation or was that You calling me back when I lived in Atlanta?" The answer crystal clear. God wanted me to be in relationship with those who did not know the love of God available in Jesus Christ. To respond to what seemed to be an answer to my prayer of many years, I went into bargaining mode. I told God I would go into ministry if I was accepted to a seminary. After sending applications to various seminaries, they all invited me to come.

I use my years long vocational prayer as an example of how I have both sensed God's presence and providence in my life. God has directed me. Sometimes I was more aware of it than others, but God has been faithful to guide. Whether it be my vocation or a tragedy, I can trust Jesus to be my Shepherd. I have learned he hears and answers my prayers.

#### Dr. Brian Wiggins Statement Of Faith

I believe there is one living, eternal God who is Lord over everything known and unknown, who is the creator of heaven and earth and of all things visible and invisible. God has revealed Godself in the Holy Scriptures as the one true God who consists of three persons: Father, Son, and Holy Spirit. JUNE 26, 2020

Two weeks ago, I turned 63. Magically, it seems, because right alongside the pictures of my grandchildren in my head sit clear images of miles of green cornstalks rippling in the wind. Detassling corn was my first job. At my age, it takes faith just to get up every morning to face a world that is constantly changing underfoot, literally and figuratively. Last September, I heard Spirit calling and after 40 years in Minneapolis, I got up and I moved to Texas.

For months I had been watching the horrible pictures on the news of children being separated from their families at our southern border. and families sleeping on a hot bridge over the Rio Grande. I studied the immigration policies and laws of our country and something just didn't seem right. I talked to God about it and I soon realized that even though I had been in Minnesota for 40 years, I still did not have roots on my feet. I could pick up and come to Texas and see what was going on for myself. Shortly after that I saw on Facebook a group called Angry Tias and Abuelas who were helping the asylum seekers. I got in touch with the Angry Tias and the rest is her-story.

I am now one of the nine official Tias/Abuelas. Though my Parkinson's disease keeps me from walking across the bridge much even when it is open, I am still able to do the computer-based work that I did for much of much of my professional life which is communications and fundraising. I am blessed to work with women of strength and courage. My faith is challenged frequently as I work to witness, interpret and then communicate everything that is happening here at the border.

In one of my first seminary classes, we were given a choice between two books to read about "purpose." One of them was the Parker Palmer classic, "Let Your Life Speak." In it, Palmer speaks of a time of great uncertainty for him. He sought direction with a Mennonite elder who told him that not a lot of way had every opened before her, but she could think of many times when "way" closed behind her, just as effectively indicacy potential paths.

I plan to continue the next phase of my faith journey loving and serving the Lord here in Texas.

#### **Regional ZOOM Groups**

One of the parts of this work I have enjoyed the most has been the regular regional meetings with pastors and other church representatives over Zoom. Sallie and I have made them a priority during this pandemic time, with all the change, upheaval, and trauma that our churches have experienced since last March. The regional gatherings have been a blessing that God has brought to us during the pandemic. We have remained in touch with each other, supported and encouraged each other, and listened while some of us ranted and grieved. We have prayed together, shared ideas, and looked to the future. On behalf of the Presbytery, General Council:

- **approved** a revised Youth Ministry Manual for the approval of General Council.
- **received,** as a first reading, a Proposed Child & Youth Protection Policy for Mission Presbytery by the Youth Connection Committee. A second reading is docketed for the first General Council meeting of 2021.
- **endorsed** the recommendation of the John Knox Ranch Committee to enter a conservation easement agreement thro8gh the Hill Country Conservancy.
- **approved** a recommendation from the Pastoral Care Committee top move its Necrology Report to October, beginning in 2021.
- approved an updated job description for the Presbytery's Rio Grande Valley Commissioned Evangelist by the Human Resources Committee.
- **approved** a three-part recommendation of the Commission on Ministry
  - (1) That Mission Presbytery not change the minimum Terms of Call for 2021, urging sessions and congregations to express their deep gratitude to their pastors for their hard work during this pandemic year.
  - (2) That three new members be added to COM, one in each of the classes: 2021, 2022, 2023.

# Conservation Easement Overview and Motion



Over 50 years ago, leaders in Mission Presbytery had the foresight to purchase the land for John Knox Ranch and set it aside for the use of camp and retreat ministry. We were so looking forward to hosting the Oct Presbytery meeting out here at the ranch. Covid has delayed our coming together in person but not our important work.

Our 300 acres of beautiful Texas Hill Country, and our spring fed Blue Hole in particular, are unique natural resources and spiritual places that must be protected.

A conservation easement will protect this land from being subdivided or developed, forever. A conservation easement is a tool used in partnership with a land trust (which is a nonprofit focused on land conservation) to conserve natural land for generations while realizing some of the monetary value now. In exchange for committing to never subdivide or develop a portion of the property, significant funds can be generated that could be used to set up an endowment for camp ministry at John Knox Ranch in Mission Presbytery.

In this way, a conservation easement completes two major long-range goals of John Knox Ranch:

- protection for the sacred ground of the ranch and;
- financial stability in the form of an endowment that will ensure that John Knox Ranch will provide camp and retreat ministry in Mission Presbytery for generations to come.

The John Knox Ranch Committee has been working on this project for over a year. We have spoken to local experts, interviewed different land trusts, talked to past directors, and visited with private landowners as well as other camps who have set up conservation easements on their land. We have also completed a formal strategic planning process led by consultants who specialize in camp ministry sites and who have experience working with camps setting up conservation easements.

The proposed easement area is between 200 and 220 acres of the total 300 acres that make up John Knox Ranch. The proposed areas are the "nature preserve" south of Carpers Creek and the Blanco River floodplain near the dining hall. The "nature preserve" area is currently used for hiking, mountain biking, ropes challenge course, and overnight camping. If a conservation easement were to be placed on the property, we will be able to continue to use this space as we have for the last 57 years of camp ministry.

A preliminary appraisal has been conducted on the proposed easement area. A formal appraisal will be conducted as part of the process and the total number acres needs to be finalized. We can expect to receive between \$1.2 million and \$1.5 million in return for restricting the development of the property.

We have an opportunity this fall to secure funding for the easement. Our potential project has been identified as a priority to be funded through the Hays County conservation bond vote that will be on the ballot in the November 2020 election. In order to be included in the conservation bond funds, we need to secure Presbytery approval at the October Presbytery Meeting.

This project not only secures the future of John Knox Ranch, it helps fulfill our mission "to foster experiences of Christian community in the beauty of God's creation". Through strategic planning, we identified the three core aspects of a John Knox Ranch experience for a summer camper or retreat participant: Christian community, connection to nature, and excellent food that enhances interpersonal relationships. Establishing a conservation easement at John Knox Ranch enhances our ability to fulfill our mission and meet our organizational potential as a Summer Camp and Retreat Center.

Over 50 years ago, leaders in the Presbyterian Church had the foresight to purchase this land and set it aside for the use of camp and retreat ministry. Now, we have an opportunity to stand on their shoulders and grasp a vision of permanent protection for this sacred ground as well as permanent financial protection for camp ministry in Mission Presbytery.

The John Knox Ranch Committee and Mission Presbytery Trustees will present the following joint motion at the October Mission Presbytery meeting. This motion has been endorsed by the General Council of Mission Presbytery.

**Motion**: Conservation Easement

The JKR Steering Committee and the Trustees recommend that Mission Presbytery:

- (1) approve the joint recommendation of the John Knox Ranch Committee and the Trustees of Mission Presbytery that Mission Presbytery and John Knox Ranch enter into a conservation easement agreement on a portion of the property of John Knox Ranch through the Hill Country Conservancy of Texas; and
- (2) that the Trustees of Mission Presbytery be authorized to complete and sign the necessary documents on behalf of Mission Presbytery to consummate this agreement; and
- (3) that proceeds received from the completion of this agreement be placed with the Texas Presbyterian Foundation and invested to establish an endowment for John Knox Ranch.

John Knox Ranch Steering committee update 9/22/2020

The John Knox Ranch Steering committee has been diligently working on a strategic planning effort with Run River consultants over the past month.

Possible Conservation Easement

Our meetings have been extremely productive and have helped us to consider how JKR will live into our mission of fostering experiences of Christian community in the beauty of God's creation. Specifically, JKR has honed our purpose as a camp and retreat center which helps inform how we will plan for future building projects as well as programmatic additions to our calendar.

In our meetings, we realized three major themes of JKR that set it apart from other camps and speak to our purpose and mission.

\*Christian Community: JKR is/needs to continue to be intentional in relationship-building for children and adults who participate in camp and retreats at camp. Our programming and ministries are intentionally built for Christian community that transforms lives. Any additional programming will focus on intentional relationship building with God as well as with others at camp/retreats at JKR.

\*Creation: Important to the ministry/programming at JKR is our integral connection to the beauty of creation at JKR. We want to continue to be "outdoor-focused" in our programming as well as in our buildings, making sure that what we build will still encourage outdoor activities/movement and not be a 'one-stop-shop' indoors that might hinder participants from being in the beauty of God's creation.

\*Food: Good food is central at JKR. We want to continue to take pride in homemade and "camp-favorite" recipes that have become a part of the community. Family-style meals (when possible) are an important way of breaking bread together and creating this connection around meals. We will encourage outside groups who come to rent space to also eat the food that JKR provides. We are also looking at how we could find sustainable ways to grow our own food at JKR in the future and what programs might be possible around this.

Motion: Conservation Easement (See attached information from JKR Director Henry Owen)

The JKR Steering Committee and the Trustees recommend that Mission Presbytery: (1) approve the joint recommendation of the John Knox Ranch Committee and the Trustees of Mission Presbytery that Mission Presbytery and John Knox Ranch enter into a conservation easement agreement on a portion of the property of John Knox Ranch through the Hill Country Conservancy of Texas; and

(2) that the Trustees of Mission Presbytery be authorized to complete and sign the necessary documents on behalf of Mission Presbytery to consummate this agreement; and (3) that proceeds received from the completion of this agreement be placed with the Texas Presbyterian Foundation and invested to establish an endowment for John Knox Ranch.

# Conservation Easement at John Knox Ranch FAQs

#### What is a conservation easement?

Conservation Easements can be used to conserve a property in its natural state, while allowing land owners to retain many rights, including ownership of the property.

A property owner has many rights that come with land ownership, including the rights to manage its resources, change its uses, or develop the property. With a conservation easement, a landowner can limit one or more of these rights. For example, a landowner can restrict the right to develop the property, but keep the rights to build a house, raise cattle, grow crops, and hunt and fish the land.

A conservation easement is a recorded written agreement between a landowner and a nonprofit land trust, like Hill Country Conservancy. The property owner makes the decision to allow the land trust to be the "holder" of the agreement. The owner keeps the legal title to the land and together with the land trust decides which uses should continue on the property and which they want to limit. As part of the arrangement, the land trust periodically checks the land to make sure it is maintained according to the terms of the agreement.

To summarize, a conservation easement is a limit or restriction a landowner freely places on a property to protect it. It is a choice the landowner makes to preserve the natural beauty, fertile soil, wildlife, and history of their land forever. In the case of the proposed JKR conservation easement, JKR would receive payment in return for agreeing to never develop or subdivide the easement land.

### Why would we do this?

John Knox Ranch's 300 acres of beautiful Texas Hill Country and our Blue Hole Spring in particular are unique natural resources and spiritual places that must be protected. A conservation easement will protect the ranch from being subdivided or developed, forever. In exchange for selling the development rights, significant funds will be generated that will be used to set up an endowment for camp ministry at JKR in Mission Presbytery.

In this way, a conservation easement completes two major long-range goals of John Knox Ranch:

protection for the sacred ground of the ranch and;

• financial stability to ensure that John Knox Ranch will be around for generations to provide camp and retreat ministry in Mission Presbytery.

We are proposing this from a place of financial stability. Our summer camp numbers, usage numbers, and fundraising are all trending up. The John Knox Ranch Committee has been working on this project for over a year. We have spoken to local experts, interviewed three different land trusts, talked to past directors, and visited with private landowners as well as other camps who have set up conservation easements on their land. We have also completed a formal strategic planning process led by consultants who specialize in camp ministry sites and who have experience working with camps considering setting up conservation easements.

This project not only secures the future of John Knox Ranch, it also fits in with our mission to foster experiences of Christian community in the beauty of God's creation. Through strategic planning we identified the three core aspects of a John Knox Ranch experience for a summer camper or retreat participant: Christian community, connection to nature, and excellent food that enhances interpersonal relationships. Establishing a conservation easement at John Knox Ranch enhances our ability to fulfill our mission and meet our organizational potential.

## How is the dollar value of a conservation easement established?

An appraisal will determine the value of the property before and after a conservation easement is placed on the land. The value of the easement is the difference between these two figures. Appraisals need to be done with care by a qualified appraiser who is familiar with conservation easements, with local real estate conditions, and with the particular type of land use in question.

# How many acres are we considering putting under conservation easement?

We are considering putting between 200 and 220 acres under conservation easement of the total 300 acres that make up John Knox Ranch. The proposed areas are the "nature preserve" south of Carpers Creek and the Blanco River Flood Plain. The "nature preserve" area is currently used for hiking, mountain biking, ropes challenge course, and overnight camping. If a

conservation easement were to be placed on the property, we will be able to continue to use this space as we have for the last 57 years of camp ministry.

# What is the estimated value of the easement? How much could we expect in return for setting up the easement?

A preliminary appraisal has been conducted on the proposed JKR conservation easement. A formal appraisal will be conducted as part of the process and the total number acres needs to be finalized. We can expect to receive between \$1.2 and 1.5 million in return for restricting the development of the property. Those funds would be used to set up an endowment for camp ministry at John Knox Ranch in Mission Presbytery.

# How will the endowment for camp ministry at John Knox Ranch be set up?

The JKR committee will work with the Fiscal Oversight Committee and long-time ministry partner of Mission Presbytery, Texas Presbyterian Foundation to use funds generated from the conservation easement to set up an endowment designated for John Knox Ranch.

In this way, a conservation easement completes two major long range goals of JKR: protection for the hallowed ground that is JKR and financial stability to ensure that JKR will be around for generations to provide camp ministry and retreat ministry in Mission Presbytery.

### Where will that money come from?

It is the responsibility of the partner land trust (Hill Country Conservancy) to secure the funding for the easement. One place that funding can come from is a County bond designated for conservation. Our potential project has been identified as a priority to be included in the Hays County Conservation bond vote that will be on the ballot in the November 2020 election. Early polling shows a 70% approval rating for the conservation bond. If the bond vote does not pass, Hill Country Conservancy will continue to look for other funding sources for the project which could take several years.

# If the money comes from Hays County through a bond vote, does the County set the rules for what we can do?

No, with a minor exception. The exact rules and language are set during a negotiation between John Knox Ranch and the partner land trust, Hill Country Conservancy (HCC). The land trust's role as "primary holder" is to partner with the landowner long term to ensure that the easement agreement is being followed. They can also provide resources and planning to help us create and enact habitat conservation and restoration planning. A land steward from the Hill Country Conservancy will schedule annual monitoring visits to the property. These occasions provide an opportunity to answer questions or respond to concerns, and provide technical resources.

Because Hays County will be making a financial investment in the conservation easement, they would reserve the rights to be a "backup holder" of the easement. In the unlikely case of Hill County Conservancy not fulfilling its responsibilities, the county would then have the right to replace HCC as the primary holder. To date, there is no known instance of this ever occurring on related agreements in Texas.

### What Land Trust would we partner with?

We would partner with Hill Country Conservancy. They are recognized as a regional and statewide leader and have been great to work with so far and have acted as an engaged partner throughout the exploration process. Learn more about them at their website. https://hillcountryconservancy.org

## If we put a conservation easement on the property, do we need to allow public access such as that for a public park?

No. Landowners retain control of access to their property. They may choose to allow access to specific groups or the general public in their conservation easement agreement but are not required to do so, other than access that is required to allow the monitoring of the property by the organization that holds the easement (the land trust).

Hays County has indicated it would seek limited forms of public access, on a by-appointment basis which would not interfere with JKR operations or cause damage to the land or water. Details on this limited form of access are negotiable.

### Why now?

There are several reasons that make this an ideal time to pursue a conservation easement:

- The potential for funding the entire project through the Hays County conservation bond.
   Funding conservation easement can take years and we have an opportunity to get it done this year. The last time Hays County did a conservation bond was in 2007 or 2008.
- Establishing an endowment is sort of like planting a tree. The best time to do it is 50 years ago. The second best time is today. Covid19 has reminded us once again how important having an endowment is for an organization. An endowment also encourages large gifts from donors to the endowment.
- We have recently completed strategic planning for John Knox Ranch. The conservation easement project is a part of that long range plan.

# Will we be able to continue to use the property for camping, hiking, etc?

Yes! We will retain the rights to use the property as we have for the last 57 years of camp ministry.

# In the future can we add new trails, trail signage, repairs to the ropes course, new primitive campsites?

Yes! The JKR Committee is completing a guided strategic planning process. One of the goals of the process is to identify any future use of the proposed conservation easement property so that we can work with Hill Country Conservancy to build those rights into the agreement. This would be things like: repairing the ropes course or adding a new element to the ropes course, adding a composting toilet for campers and hikers, adding new hiking or biking trails with appropriate signage, etc.

# What buildings might we want to add to JKR in the future? Do we have enough space for them if we do the conservation easement?

As part of the strategic planning process, the JKR Committee is working with specialized consultants to identify any future buildings that might be needed for future programming. We have identified 3 potential locations for large buildings (retreat center, alternative dining hall location) that are not in the flood plain or in the proposed easement area. We have also identified several potential areas for smaller buildings (new cabins or health care center). We feel confident that by excluding 80-100 acres from the conservation easement we are retaining the space we need for any future buildings we may need to fulfill our mission.

# Will Mission Presbytery retain the title to the property?

Yes, Mission Presbytery will retain the title. We would not be selling the property, only encumbering a portion of the property with development restrictions.

### Can we still sell the property in the future?

Yes, a property with a conservation easement can be bought and sold. However, the conservation easement is tied to the land and binds all present and future owners to its terms and restrictions. Setting up a conservation easement on the nature preserve at JKR, permanently protects the land from development and preserves its natural state for generations to come.

### Is the conservation easement reversible?

No. Conservation easements offer permanent protection from subdivision and development.

# Are there any costs associated with setting up a conservation easement?

Yes. There are legal costs associated with setting up a conservation easement as there are with any real estate transaction. These costs include things like appraisals, surveys, legal fees, etc. Ordinarily these costs would be paid out of the funds received by setting up the easement, however, John Knox Ranch has applied for and received a grant for \$35,000 from the Hershey

Foundation designated toward paying the costs of setting up an easement. This is the first grant from the Hershey Foundation to JKR. If for any reason the conservation is not set up the grant for \$35,000 will need to be returned to the foundation.

# Can we hold chunks of the land out of the easement so that we can build in the future?

Yes. A limited number of small "building envelopes" within the proposed easement area can be reserved so that they can be built on later. For example, as part of the strategic planning process, the JKR Committee identified a potential future need for additional on site staff housing. The very back southern property line of JKR would be an ideal area for staff housing, therefore we intend to reserve a small building envelope for this potential future use.

### Have any other camps done this?

Yes, we have spoken with several camps who have entered into conservation easements. Some view their experience as positive; others had negative experiences.

The distinguishing factor between a positive and negative experience seems to be the amount of planning done before entering into the agreement and the financial state of the camp before the agreement. The camps that had positive experiences spent time carefully planning the program and facilities before the agreement and were in a stable financial position. One camp, Clearwater Forest Presbyterian Camp in MN, has entered into two separate conservation agreements with tremendous success. The funds generated were used to make repairs to facilities and set up an endowment for camp. Montreat Conference Center currently has 2,460 acres under conservation easement and views it as a "real blessing". They highly value their partnership with their land trust which has helped advise them on land management.

The camps that had negative experiences were close to closing due to financial issues and viewed the conservation easement as the solution to keeping them open. They tried to maximize the amount of funds generated and didn't leave any space for future development of camp buildings. One of these camps is now closed. Even in that case however, the silver lining is that the land will still be protected.

Dear Rev. Crouch,

As a former Executive Director of both The Nature Conservancy in Texas and the Texas Parks and Wildlife Department as well as a lifelong Presbyterian, I am thrilled that the Presbytery is considering protecting important portions of John Knox Ranch with a conservation easement.

First and foremost, to take this action would permanently protect some of the most critically endangered landscape in the United States. As you know, Hays and Comal Counties are among the fastest growing counties in America and lands along the Blanco River particularly, are considered among the most threatened. Protecting them forever would not only ensure that many generations of children would continue to be inspired by the outdoors at John Knox but would send an important message from the denomination that we take seriously the fact that the earth is a gift and protecting it is the special privilege of humanity.

Finally, protecting critical portions of John Knox Ranch in this way would in no way inhibit its educational, recreational, and spiritual mission and would potentially put the Presbytery in a position to receive grant funds which could be used to endow the Ranch ensuring that the land and the camp ministry program are both protected for generations.

Very regularly, I am approached by young people engaged in conservation careers who tell me they were inspired to this calling by spending summers at John Knox Ranch. Protecting it forever would honor those who it has moved to dedicate their lives and ensure that other youth will do so in the future.



#### **Report of the Commissioned Pastor Task Force**

#### of Mission Presbytery

#### October 26, 2020

Task Force members Andy Anzaldua, Kris Bair, LaVerne (Sam) Baublit, Ann Brizendine, Bill Cotman, Linda Bourianoff, Duane Manning, and Sallie Watson reviewed the present program in Mission Presbytery, as well as those in other presbyteries, notably the Presbytery of Northern Kansas. We spent the summer wrestling with definitions, requirements and protocols, keeping the core curriculum of the present program, but setting up clear boundaries and guidelines. This program would put CPM in charge of recruitment and training, and move Certified Ruling Elder graduates of the program into the care of COM. It would also create a new category of lay pastors commissioned to the presbytery-at-large, also under COM care. Finally, it provides a protocol for the certification of CREs, or CREs in process, transferring in to Mission Presbytery from another presbytery. We bring five motions to enable the program that following this page.

#### **Motions**

#### GC Member Kris Bair moves for the CP Task Force

- 1. that Commissioned Ruling Elders (CREs) who have previously served as Commissioned Pastors (CPs) may also, *at the recommendation of Committee on Ministry (COM)*, be commissioned-at-large to the presbytery to serve as *pulpit supply* to various congregations. In addition, they may administer the sacraments to the congregation being supplied and serve presbytery functions in the same way, with approval of the appropriate COM liaison for each function. CPs-at-Large shall have their names placed on presbytery's pulpit supply list.
- 2. that Committee on Preparation for Ministry (CPM) be charged with the recruitment, training and certification of Ruling Elder candidates desiring to become Certified Ruling Elders (CREs).
- 3. that COM be charged with the care and oversight of CREs who have completed the program and been authorized by CPM to receive a commission, and to maintain a roster of active CREs, coordinating with CREs and congregations to facilitate placement.
- 4. that General Council adopt the *Commissioned Pastor Training Program* presented by the CP Task Force for training and utilizing CREs in Mission Presbytery, along with the Guidelines for Transferring Certified Ruling Elders (CREs) from the programs of other presbyteries or denominations into the Certified Ruling Elder Program of Mission Presbytery.
- 5. Should all, or the last three, motions above be adopted, the CP Task Force be dissolved.

#### **Definitions of Terms**

**CREs** (Certified Ruling Elders) are those individuals who have completed a ruling elder certification program recognized and approved by Mission Presbytery (MP). A CRE is not currently commissioned to a church or the presbytery-at-large.

- a) CREs may preach in any church when invited by the session.
- b) CREs may administer sacraments during worship if the session has received approval from the Committee on Ministry (COM) Liaison to that church.
- c) CREs may moderate session meetings if invited by the current moderator to that session to do so, and the COM Liaison to that congregation has been informed.
- d) CREs may be appointed by COM to moderate sessions lacking a moderator.

**CPs** (Commissioned Pastors) are CREs commissioned by MP to a particular church. CPs may moderate sessions and serve the sacraments, but only to the church to which they are commissioned. If requested to serve additional churches during that time, they will follow the protocols above for CREs.

#### **CPs-at-Large**

CREs who have previously served as CPs may also, at the recommendation of COM, be commissioned -at-large to the presbytery to serve as pulpit supply to various congregations. In addition, they may administer the sacraments to the congregation being supplied and serve presbytery functions in the same way, with approval of the appropriate COM liaison for each function. CPs-at-Large shall have their names placed on presbytery's pulpit supply list.

#### **Statement of Purpose**

Mission Presbytery joyfully affirms the need for Ruling Elders to be certified and commissioned for ministry in our congregations. *Hearing the calling of God through the Great Ends of the Church, Mission Presbytery commits itself to meeting this need.* Commissioned Pastors (CPs) share their gifts, as they serve the congregations to which they are called. The CP program provides an academic track to prepare Ruling Elders for a commission to a particular congregation, and continuing educational opportunities that allow CPs to grow in their pastoral identity while serving a congregation. This program also contains procedures to welcome and examine Certified Ruling Elders (CREs) joining Mission Presbytery from other presbyteries or denominations, and protocols for calling CREs as CPs to a congregation or to the presbytery-at-large.

#### Oversight of the Program and the CPs

The Committee on Preparation for Ministry (CPM) is charged with the training and certification of Ruling Elder candidates desiring to become Certified Ruling Elders (CREs).

COM is charged with the care and oversight of CREs who have completed the program and been authorized by CPM to receive a commission, and will maintain a roster of CREs, coordinating with CREs and congregations to facilitate placement.

**Recruitment, Admission and Funding Protocols** for the program are the responsibility of CPM.

**Curriculum**—these may be met via face-to-face or virtual meetings

1. CREs must complete coursework from an approved seminary (Union, Dubuque, or Austin Presbyterian Theological Seminaries; others approved on a case-by-case basis), to include the following or their equivalents:

Old Testament PCUSA Polity

New Testament Reformed Theology Worship and Preaching

Christian Education

Church History

History/Multi Ethnicity of MP--could be completed by working with assigned Mentor

Basic Church Management ----could be completed by working with assigned Mentor

2. Required practicums (½-day sessions, 2 per year) will provide CREs opportunity to develop proficiency in fulfilling specific responsibilities to the congregation, and should also include use of appropriate resources (*Book of Order, Book of Common Worship, Book of Occasional Worship*, etc.) Practicums are organized by CPM. Required subjects include the following:

Worship/Liturgy (occasional services)

Preaching

Sacraments

Weddings/Funerals

(Other topics as CPM deems necessary)

3. CPM will provide each candidate with a **mentor** to supervise coursework and provide advice and encouragement during the process. CPM determines parameters for completion of coursework and standards expected, and shall communicate these clearly to candidates (see attached flow charts).

#### **Evaluation for Certification**

After coursework and practicums are completed to the satisfaction of CPM, candidates are expected to

- Preach a sermon, turning in the written copy with a complete bibliography of works consulted;
- Write and submit a Statement of Faith;
- Provide a resume:
- Complete a written exam, if required by CPM;
- Complete a psychological evaluation.

CPM is responsible for administering and scoring these requirements, and determining pass/fail status for each candidate.

#### Post-Certification

In addition to maintaining a list of active CREs available for a call, and facilitating such calls in apt situations, COM will

- Assign each CP a mentor (through the appropriate COM regional representative) at the time of commissioning, with expectations for monthly contact between CP and mentor for mutual support/problem solving. The CP and mentor assume mutual responsibility for monthly contact.
- Evaluate the CP as any other pastor in service to a congregation, keeping in mind any limitations in the call itself and the nature of the CP classification.
- Require CPs to take Boundary Awareness Training and any other training required of active TEs in MP.
- Ensure that CPs are active in the presbytery, attending presbytery meetings with some regularity, attending regional cluster meetings, and serving on presbytery committees according to their gifts and abilities.
- Like TEs, CPs must take advantage of continuing education opportunities, which may include Theocademy courses (online, many available in Spanish, and free); Interim Training; workshops at presbytery meetings, conferences and pastors' retreats; APTS Midwinters, Association of Presbyterian Church Educators, Festival of Homiletics, the Big Tent, etc. Their COM mentor should provide guidance for Continuing Education choices.

Guidelines for Transferring Certified Ruling Elders (CREs) from the programs of other presbyteries or denominations into the

#### **Certified Ruling Elder Program of Mission Presbytery**

CREs transferring into Mission Presbytery (MP) and wishing to be considered as "Available for Commissioning" or desiring to apply for admittance to the MP CRE Program, will

- 1. Complete and submit the MP CRE application.
- 2. Provide written documentation from the institution/instructor/presbytery that provided any previous education/training for which the individual is requesting CRE credit. The Committee on Preparation for Ministry (CPM) will evaluate the documentation in order to determine the status of the candidate.
- 3. Provide references from the last congregation(s) served, if applicable.
- 4. Wait while Presbytery leaders consult the leadership of the presbytery in which the CRE trained and/or last served as to the candidate's status. If the report is good, complete a criminal background check.
- 5. Meet with the CPM for the required initial interview, during which questions about faith journey and sense of call will be asked. CREs who have served as CPs will also be asked questions about their previous calls.
- 6. Complete all requirements of the MP CRE Program as outlined by the CPM. Requirements will be evaluated on a candidate-by-candidate basis, and some may be waived, or substitutions accepted, in the case of CREs with CP experience.
- 7. Complete a psychological evaluation.

When the CRE candidate has met the requirements, and the committee has agreed he or she is ready to serve, Committee on Ministry (COM) will be notified the CRE is ready for a call.

PCC Report to General Council September 22, 2020

Motion:To have the Presbytery Necrology Report in October (starting 2021) so it is closer to All Saints Day.

Description of PCC as it has evolved in 2020:

- 1. We perceive our main tasks to be the pastoral care for pastors, CLP, Christian Educators, and their families in times of difficulty and to enhance the general well-being and resilience of MP pastors, CLE and Christian Educators.
- 2. How we function: Sallie contacts Marsha who contacts a team member who contacts the pastor in need of care; then team member reports back that they made contact and Marsha reports that to Sallie. All information is confidential between the PCC member and the pastor in need of care- unless life is in danger. Follow-up is as needed.
- 3. When COVID 19 first hit, we contacted as many pastors as possible to offer support for the stress involved; especially chaplains and small church pastors and leaders.
- 4. We assist with HR announcements, obituaries of churches that close, and minister obituaries for the newsletter.
- 5. We have offered a pastoral retreat at Mo Ranch for pastors and CLPs and Christian Educators renewal and rest in 2019 that we hope to continue in Fall 2021.
- 6. Possible merger of ECN and PCC is on hold for now.
- 7. Next Meeting: Friday Oct. 29, 2020; 10am-12pm on Zoom.

## Education and Congregational Nurture Committee Report to Presbytery October 12, 2020

The ECN Committee met on July 21 and September 15, 2020 via Zoom.
