# **GENERAL COUNCIL'S REPORT TO MISSION PRESBYTERY October 23, 2021**

## **GENERAL PRESBYTER'S REPORT, TE SALLIE WATSON**

- Sallie updated the GC about the work of the strategic planning team. They've named themselves "Mission Forward." The GC is invited to a Mission Forward retreat the weekend of January 21-22 at Mo-Ranch.
- Conversations have started with Communications Services at Synod to update the Mission Presbytery website. Caitlin has done good work helping us to think about a better way to organize the site. If you have any ideas about the website, send them to the presbytery staff.
- Sallie is thinking about ways to have Spanish and Korean translations available for presbytery meetings. She's researching this. After discussion, GC asked that she contact churches to see what the interest is regarding this before making a decision.
   Dries reminded GC that we agreed to have the newsletters translated. Sallie will follow up on both of these issues.
- Education and Congregational Nurture, ECN, has been on sabbatical this year but has done some creative work. More information will come in its report.
- A motion was made that Church Development and Evangelism Committee be dissolved. The motion was seconded. The motion passed.

Ezequiel Herrera's position as Rio Grande Valley Evangelist will not be affected by this. Sallie called attention to the disbursement of funds from church property sales in Dropbox. The 10% that was to go to CDE would still go for development and evangelism, even without a formal committee. A motion and second were made to approve this language, and the motion passed.

## STATED CLERK'S REPORT, TE LAURIE PALMER

- Laurie reminded GC to send in 2021 Terms of Call and the names of Ruling Elders and Deacons who died in 2020 for the necrology at the October 23, 2021 presbytery meeting.
- The General Council approved these minutes:
  - May 8, 2021 GC meeting
  - o June 19, 2021, Mission Presbytery meeting
- The 2022 Mission Presbytery Meeting dates are March 4-5; June 10-11; and October 21-22.

## **GENERAL COUNCIL REPORT, TE STACY IKARD**

- PDA truck: \$40,000 has been raised for this. \$20,000 is still needed.
- RE Fred Gamble, chair of Fiscal Oversight, presented the proposed 2022 budget.
   After discussion and edits, a motion was made to approve the 2022 budget as amended, followed by a second. The motion passed. The 2022 budget will go into the 10/23/2021 Mission Presbytery meeting packet.
- Fred presented the Distribution of Funds from Church Property Sales. FO moves the following:
  - 10% to General Assembly

10% to Synod

10% for church development and evangelism

10% to the Mission Presbytery Trustees for their work closing churches

60% to the General Fund or at the designation by Fiscal Oversight.

## The motion passed.

• Follow up on the Synod level Presbyterian Disaster Assistance position, to which the GC voted to contribute at the last meeting: Fred reported the Fiscal Oversight discerned that it could support this position with \$50,000.

Kris moved the following committee chairs be elected by GC, and they were approved.

## **EDUCATION AND CONGREGATIONAL NURTURE, RE SAM BAUBLIT**

Sam brought two motions from ECN:

- 1. To change the name of the Education and Congregational Nurture Committee to the Faith Formation Committee. After giving rationale, the GC approved this change.
- 2. To approve the handbook for the work of the Faith Formation Committee, which the GC approved.

## YOUTH CONNECTION COMMITTEE (YCC), TE ELLEN HENSLE

Covid continues to impact this ministry. Originally planned to be in-person at Mo Ranch, Main Event has been moved to online.

## MISSION AND JUSTICE OUTREACH (MOJC), TE DRIES COETZEE

Dries brought the following motions from the committee:

Firearms of any kind are not allowed to be present at any Mission Presbytery meeting.

The Presbytery will hold meetings only at facilities that provide legal effective notice of "NO FIREARMS" posted at the day and time of the event.

Procedures: • In advance of any scheduled Presbytery meeting to be held at a designated venue, the Presbytery Moderator shall provide notice to the venue of this policy and request that the venue assures that the policy will be honored

- The Presbytery meeting venue leadership shall provide advance assurance that this policy will be upheld for the scheduled date and times of the meeting
- The meeting venue leadership shall ensure posting of the Texas Penal Code Section 30.05 sign at all public entrances or provide cards to attendees prohibiting entry of any person with a firearm
- At the scheduled meeting, the Moderator shall make an announcement to the assembly reiterating the no firearms policy and request that anyone in attendance with a firearm remove it from the premises to a vehicle or secure an off-premises location
- Enforcement of this policy will be delegated to the meeting venue leadership.

This proposed policy will go to the 10/23/2021 meeting of Mission Presbytery for a first reading.



The Stewardship & Fiscal Oversight Committee (SFOC) presents, in addition to the usual line-item budget, this narrative budget to show more graphically where Mission Presbytery's money comes from in broad categories and where the money goes using the four categories of the mission statement above. We hope this will allow for a better understanding of the presbytery's finances and will encourage increased generosity by our congregations so that we are best able to finance the mission of the presbytery.



## **INCOME**


The presbytery receives incomes in five main ways:

- 1. Benevolence: churches' contributions to the presbytery
- 2. JKR/Midwinter: income from campers at JKR and income from fees with Midwinters
- 3. Leases/Principal Received: money from leases and money from principal repaid to the presbytery for loans
- 4. Interest/Designated funds: money accrued from interest on accounts (for example, the Texas Presbyterian Foundation, or from bank accounts), and from designated funds
- 5. From financial reserves



## **EXPENSES**

The presbytery uses its income to accomplish its mission. Mission activities are categorized according to the four parts of the mission statement on page one.



You will note that there is no "slice" for personnel, even though it is an integral part of the budget. We asked our staff to estimate the amount of time they spent in each of the four ministry areas and added that percentage of the personnel costs to the other expenses in each category. We did the same with other overhead expenses.



When one individual church makes cleanup buckets, they are a mighty force when combined with other churches efforts to address a major disaster.

We assigned the work of the presbytery committees to the Mission Statement categories as follows:

1. Establish and equip congregations and sessions to carry out their missions (includes \$213,088.98 or 15% of expenses). This category includes the committees for church development and evangelism work, the Committee for Education and Congregational Nurture, the Committee on Ministry, and the General Council.

Recruit, receive, ordain, develop, and care for those called to service in the church (includes \$185,449.71 or 13% of expenses). This includes the Committees on Preparation for Ministry, Representation and Participation, Pastoral Care, and the Permanent Judicial Commission

3. Enable mission and witness to the gospel that congregations cannot accomplish alone (includes \$851,475.58 or 60% of expenses). This includes the committees for Mission Outreach and Justice, Presbyterian Disaster Assistance, Youth Connections, along with Presbyterian Women and John Knox Ranch.

Mission Presbytery consists of about 100 PCUSA churches from near El Campo, to Lampasas, to Del Rio, and all the way to the Rio Grande Valley. We have a huge presbytery with many characteristics: very urban, very rural, and very diverse in many ways. Hundreds of miles of the US/Mexico border are part of our presbytery.

We work together to help each member church - whether to find leadership, or new ideas for direction, or helping with repairs or construction.

We work together on many pressing needs: people stuck at the border, people affected by weather events, people who are homeless or dealing with food or shelter insecurity. Yet, we always have an eye out for the larger picture in the US and the world as well.

Each of our churches works in its own situation, but we all need to lean on each other at times, draw strength from each other, and in some ways do things an individual church could not do. We pool some of our resources together and can work together for the demonstration of God's kingdom on earth.

We invite your church to partner with us in ministry. When we pool our disaster kits and hygiene kits, we make a difference to those affected. When we deliver supplies, or portable showers, or large generators into disaster areas, we make a difference. When we tend to migrants on the border, we make a difference. When we volunteer to work on committees from various churches, we make decisions that make a difference.

We, the members of the Stewardship and Fiscal Oversight Committee, encourage you to join with us individually and as a church to support your presbytery. We are so much better together!

## Statement of Faith: Rev. Jonathan Watt

Thanks be to God for these amazing gifts of grace and mercy.

## Journey of Faith: Rev. Jonathan Watt

Walking a path of faith is always an adventure, full of highs, lows, epiphanies, questioning, and doubt. I was prepared for my own journey by parents who were heavily involved with our church as I was growing up. This set the stage for my first tangible experience of God, which occurred during a week of camp when I was in the fifth grade. Being in God's amazing creation, spending time with friends, singing and learning about God during this week brought my spirit to a mountaintop and I reveled in the closeness I felt with God. Immediately upon returning home, I asked to be baptized by our pastor at First Presbyterian Church, in San Antonio, as I had not been baptized as an infant.

From this high point of faith I entered a relatively stable period of small ups and downs, through middle school, confirmation, and into high school. In high school, however, I became increasingly discontent with the inconsistencies I witnessed within the church and began a trek deep into valleys of doubt. My faith, which I had clung to so strongly as a child, did not fit as well as it once had, as I became more aware of the broken world in which we live; I did not understand how a loving God could allow so many bad things, or so much pain, into God's good creation. Though I didn't stop going to church altogether, I spent most of my late teens and early twenties walking through this valley, occasionally bouncing from church to church, and never settling in one place for more than a few months. Though I could sense God's call upon my life even during this time of wandering, I did not understand what it was or what it meant.

Then, towards the end of my college career, a class on religious literature not only taught me to think of faith in a new way, it roused my desire to learn about and serve God. Each week we delved into challenging theological and philosophical conversations based upon the assigned readings. I looked forward, with great anticipation, to each class and began to feel like a long-dormant part of my spirit was awakening.

After graduation, I literally ran the rest of the way out of the valley and began the trek into my current life of faith. During this time I was a dedicated triathlete and spent a great deal of time swimming, biking, and running. It was during these training sessions that I began to pray and to listen for God's word. With each passing day I experienced God's call upon my life a little more strongly. This call led me to return to First Presbyterian, in San Antonio, where I began meeting regularly with one of the pastors to discern its meaning, and eventually to Wake Forest University's School of Divinity, where I earned my M.Div. and completed the ordination process to become a Minister of the Word and Sacrament within the PC(USA).

Following graduation, I began my ministry at Highland Presbyterian Church, in Winston-Salem, North Carolina, first as the Director of Youth Ministry and then as their first Associate Pastor for Youth. After five wonderful years there, I felt God calling in a new direction, and so became the Pastor of St. James Presbyterian Church in Jenks, Oklahoma, a suburb of Tulsa.

I am very grateful for my five years of ministry at Highland and the last eight at St. James. I have been privileged to be with members and guests during many of the key times in their lives, and to share my faith and love of God with them. I have also been privileged to walk alongside them during their own journeys of faith.

My own journey is the work of a lifetime, and so is still ongoing. The pandemic and challenges of this last year, especially, have reminded me of the amazing ways the Spirit continues to work even through the most trying circumstances. Regardless of what comes in the future, I am confident that, through it all, I may rest securely in the grace of our Lord, Jesus Christ, the love of God, and the strength of the Holy Spirit as I continue to discern what it means to live as a disciple of Jesus Christ.

## Statement of Faith Rev. Sandra K. Murray July 17, 2021

I believe that the church needs to be responsive to the needs that many people have living in a broken world. Many people are hurting because of prejudice, fear, and isolation. It is important to help hurting people come to know the love of Jesus Christ and to help them discover the church as a place where healing can begin. I believe that the church can do this through worship, prayer, outreach, and being open to the needs of those around us.

I believe in the equality and essential dignity of all humanity. All persons are made in the image of God and are to reflect that image through their giftedness in the community of believers and in society.

While I believe that the local church is not the only place you practice your faith, I also believe it is almost impossible to experience the full accountability, encouragement, and support you receive from face-to-face fellowship with other believers without active participation in a local church. I strongly believe that participating in a local fellowship is crucial to the spiritual health and balance of every believer. Through the support, accountability, and encouragement I receive in my local body, I am able to extend a practical expression of my faith through my involvement in mission both locally and internationally. I believe that as members of Christ's Body, we are to do the works of God as revealed by the Holy Spirit and to share the good news of the Word to bring glory to God.

## Journey of Faith for Sandra K Murray:

As I reflect on my faith journey, I realize that God has been working in my life since I was a little girl. My memory is that as a six-year-old, I went to the church across from my school and asked if I could come to Sunday School. That may be somewhat apocryphal, but I know that I have had a sense of call from an early age. I felt God's nudging when in the 5<sup>th</sup> grade and I told my Sunday School teacher I was going to be a missionary. I remember, hearing a woman preach for the first time in 1960 and I thought "Maybe I can do that." As I grew up and my life took a different direction, I never completely lost that sense of call.

After, high school I joined the US Army and then I went to college on the GI bill. I graduated from Solano College and San Francisco State University with a major in history and elementary education. I got married, had a son, and completed by California Teaching Credential. During that time, I was in the church sometimes and then I was outside the church. I had somehow lost my direction. In 1975, I found myself as a single mom trying to earn a living and care for my son. At that point in my life, I found myself returning to the church. I became actively involved in the Oxnard Presbyterian Church. I taught Sunday School, was superintendent of the Sunday School, participated in Bible studies and I began to rediscover my sense of Call.

In 1977, I began to explore what that call might mean. I was in a workshop in Ventura, CA and we were looking at Ephesians and Paul's talking about gifts and how we needed to use them. The leader asked us to discuss "what would we do if there were no barriers, no cost, nothing to get in the way?" I blurted out "I would go to seminary." I had never expressed that before and it was a turning point for me in that I realized if I would do that if there were no barriers, I needed to do that even if there were barriers. In 1978, I entered in the MDiv program at Fuller and in 1979 I transferred to San Francisco Theological Seminary. I graduated in 1981 and was ordained later in 1981.

I have served churches in Idaho, Pennsylvania, Florida, and Michigan over the last 40 years. I have always had a passion for Mission and when I retired in 2011, I became more focused on that aspect of my call. I served two years as a volunteer in mission to Samaritan House in Las Vegas, New Mexico. After that I decided to do a year as an AmeriCorps Vista in Tucson, Arizona working with homeless programs.

I came back to Michigan the end of 2015 and took the position of Chaplain at the Father Fred Foundation in Traverse City, Michigan. I was the pastor to our clients, volunteers, and staff. I helped with financial aid and any other task they needed me to do from working in the pantry, to clothing and intake.

The call to lead God's people is a call to live as a mature Christian. For me, this means, "not taking yourself too seriously, but taking Jesus Christ very seriously". One indispensable gift I can possess, therefore, is a sense of humor and an appreciation of the unexpected. Humor is God's gentle reminder of our own fallibility and of the futility of our subtle attempts to force God into the box of our own desires and expectations. Over the last 50 years or more, I have tried to take my sense of call very seriously and attempt to live my life in faithful service. When I left Traverse City, I was reminded that I was starting a new adventure. I do not know where I am being led but I am trying to listen carefully to God's nudging in this my new adventure.

#### STATEMENT OF FAITH

## The Rev. Dr. Johanna Elizabeth (Jobeth) Tice McLeod, Honorably Retired from the Presbyterian Church (USA)

When I affirm my faith, using the Apostles' Creed or the Nicene Creed, I profess my belief in the holy catholic church or the one, holy Catholic and Apostolic Church. In other words, I am affirming that I believe in the universal church, to which all Christians belong. Like most other Christian traditions, the Reformed Tradition affirms belief in the sovereignty of God; the Trinity; the Incarnation; the actual life, death, resurrection, and ascension of Jesus the Christ; salvation by grace through faith; the continuing presence of the Holy Spirit, the fellowship of the saints, and the sure and certain promise of eternal life. What sets the Reformed Tradition, and specifically the Presbyterian Church (USA), apart is the emphasis on certain beliefs and specific practices, such as:

- a. The Bible is the inspired and revealed Word of God, from which we derive our rules of faith and practice. Our Confessions and our Book of Order are second and third in order of priority in matters of faith and practice.
- b. God, the Father, is the one, holy, infinite, sovereign creator of all things, the Lord of the human conscience, and will be the merciful judge of all people at the end of time.
- c. Jesus Christ, the Incarnate Word and Son of God, through His perfect life, salvific death and miraculous resurrection from the dead, became the atonement for the sins of the world, and is the evidence of the promise of eternal life for all who believe in Him.
- d. The Holy Spirit is our sustainer, comforter, and guide in this earthly life, who with the Father and the Son is to be worshiped and glorified.
- e. The Sacraments ordained by Jesus Christ himself are Holy Communion and Baptism. Holy Communion is open to all persons who profess faith in Jesus Christ as their Lord and Savior, regardless of their church affiliation. Baptism may be administered by sprinkling or immersion, and at any age, including infant baptism.
- f. The Presbyterian Church (USA), as a part of the Reformed Tradition, seeks to spread the Good News of God's redeeming and reconciling activity in the person of Jesus Christ; continues to be the church reformed and always needing to be reformed; and testifies that believers are saved through their faith, not their merit, by God's grace alone.
- g. The Presbyterian Church (USA) is connectional and should be governed decently and in good order by the Sessions of local congregations, the Presbyteries, the Synods, and the General Assembly. Men and women may be ordained to the offices of Deacon, Elder, (Ruling Elder) and Minister of Word and Sacrament/Pastor/Teaching Elder.
- h. Presbyterians affirm our unity with other Christian traditions and together share with them in working for peace, unity, purity, and reconciliation in the world.

This is not an exhaustive list of the tenets of the Reformed Tradition or the Presbyterian Church (USA), or my beliefs. However, it is an outline of the core beliefs I have been taught since my childhood, and which I sincerely embrace and affirm. Above all, Jesus Christ is my personal Lord and Savior, and my

only hope of salvation. Therefore, as a faithful and obedient servant, I have answered God's call to both lay and ordained ministry, humbly responding by using the words of Isaiah, "Here am I, send me."

### **FAITH JOURNEY**

Rev. Dr. Johanna Elizabeth Tice McLeod, Honorably Retired from the Presbyterian Church (USA)

My sister and I were figuratively and literally born into the Body of Christ (Corpus Christi, Texas) and grew up as sixth generation Texans on a family farm near Sinton, Texas, and in the Sinton Presbyterian Church. Our father, H. Robert Tice, was an elder and the church treasurer for over 50 years. Our mother, Martha E. Pool Tice, has been a Sunday School teacher and a Bible moderator for over 60 years. The promises made for me at my infant baptism were kept, not only by my parents, but also by my church family. As a child I accepted Jesus Christ as my personal Savior and was confirmed at age eleven. My faith was nurtured by Sunday School teachers and pastors, church camps, youth leadership training at Mo-Ranch and Montreat, by serving on the presbytery's Sub-Committee on Youth, and by attending and graduating from Austin College.

God's direction for me to attend seminary came during private prayer. Initially I was surprised by the suggestion that I should attend seminary. I literally argued with God, suggesting that I was already a Christian attorney and I could do more good for the Kingdom serving the poor and powerless, and furthermore there was no seminary for me to attend in San Antonio, nor could I leave my husband and young son and move to Austin to attend Austin Presbyterian Theological Seminary. However, since with God nothing is impossible, I earned a Master of Theological Studies degree from Oblate School of Theology and completed an internship with Christian Conciliation Service, settling legal disputes outside the civil court system. It seemed like the ideal way to combine law and theology, so I set aside another year to work with CCS to discern if God was calling me to this ministry full-time. On Ash Wednesday of that year, I remember praying, "God, you know, WE have not yet made up MY mind about what I should do next." Before I could continue, God broke in with, "BUT I NEED YOU ORDAINED." I immediately realized that would mean returning to school, again. However, this time I knew better than to argue with God any more, and furthermore I had no desire to do so. In an instant God transformed my heart. What God wanted for my life and for my vocation became what I wanted for my life and for my vocation, so I said, "May Your will be done in my life." I did make a big request, which was that God would make obvious and clear before me the path I was to follow concerning schools and degree programs. That prayer was answered very specifically, and with the permission of Mission Presbytery, I attended both Oblate School of Theology and Austin Presbyterian Theological Seminary.

Along the way, during and after seminary training, I practiced law and taught mediation, family mediation, and legal ethics at National Christian University School of Law, and then taught world religions, ethics, and government at Northwest Vista College. During the summer before my daughter left home to attend college, my PIF was sent to the COM of Tres Rios Presbytery through Presbyterian Women connections, not the PC (USA) match system or self referral on my part. In my experience, God's ways are often surprising and mysterious, so I have learned to walk by faith and not by sight, figuratively and literally because I became legally blind during my seminary training. I taught myself to read again with peripheral vision by using high magnification.

Serving the First Presbyterian Church in Alpine was challenging, rewarding, and eventful. In a small congregation every person becomes a dear friend. Additionally, during that time I participated in the work of the presbytery, local and international mission projects, community organizations, and earned a Doctor of Ministry degree. I retired and returned to San Antonio just in time for the Covid19 pandemic. I still do not know exactly where God will lead next, but I intend to remain a faithful and obedient servant of Jesus the Christ to my life's end.

# Statement of Faith Rev. Stanley A. Larson

My faith as a Christian begins with Jesus Christ as my Lord and Savior. But that assertion elevates Jesus somewhat above the reality of coming to know and believe in Jesus as a friend and companion throughout my life's journey. I have seen and felt his presence in my life at times of decision and times of difficulty. There are some things I have experienced and gone through in my life that I would, at the time, wanted to not experience. But those difficult times have brought me closer to Jesus and seen how he has guided me to where I am today in my faith and life.

I have also always had a great yearning for God as creator. When I attended a Bible study training years ago, the leader helped me understand this better. He said that for our generation, we might need to add to the Apostle's Creed. It maybe should read, "I believe in God the father almighty, creator **and owner** of heaven and earth". We are so caught in possessing so much and keeping it just for ourself. I live in the understanding that all I have and possess are really given to me by God to use for a time. This means that I have no problem giving away much of what I have to follow Jesus.

This also plays out in my life and faith in the call to Abraham and to us all that we "are blessed to be a blessing". What I have from God is for me to share with others. My life is also to be lived in awareness of and service to my neighbor. The challenge is to walk through life like Jesus seeing the people whom God places in our path, not as an inconvenience but as opportunities for service and witness.

I am also very aware that much of the time, I do not see exactly what God is doing in my life and the world around me. There has to be room for the wonder and mystery of God working as the Spirit. The Spirit guides each of us every day in ways we do not see. I experienced this during my college years, when I was led to take on a roommate when I had none. We became good friends, which led to my working at our church camp, first as a counselor and then as program director.

My college experience led me to see the choices that other pastors and teachers had made to reach their present positions. That led me to see ministry as a possibility for me. I saw God's Spirit guiding me at those important decision times and I see the Spirit still guiding me today.

I strive to live out the faith I have articulated here, aware always that it is only through God's calling and gifts that I am able to be a minister to God's people in the places where God calls me.

### STATEMENT OF FAITH

- i. I believe in the one triune God who exists as the Holy Trinity: Father, Son, and Holy Spirit. The trinity exists in eternal relationship with each other and temporal relationship with all of creation. God created the world and all things good to reflect God's goodness.
- ii. Through God's original blessing, humankind was created in God's image and called *very good*. We were created to be in relationship with God and with each other from the very beginning. Humans separated ourselves from God, and continue to separate ourselves, by violating the image of God in ourselves and others. God did not, and does not, abandon creation. God continues to faithfully pursue unfaithful people.
- iii. God demonstrated love for humanity by becoming human in Jesus Christ, the Word made flesh. Jesus is fully human, and also fully divine. He was crucified and died, and through his death on the cross, we are justified into right relationship with God. Jesus was resurrected from the dead and he ascended into Heaven.
- iv. We do not, and cannot bring about our own salvation. Salvation is a free gift of God's grace, initiated by God through Christ. Therefore, our ability to confess Jesus as Savior is not what saves us; it's a response to what God has already done. Our justification restores us to right relationship with God.
- v. The Holy Spirit continues to work, transforming us, sanctifying us, and restoring us to the image of God.
- vi. The Sacraments of Baptism and Holy Communion are outward and visible signs of an inward seal of God's grace. Through the waters of baptism, we are grafted to Christ and included in covenant community as children of God. Through the physical elements of the Lord's Supper, we remember Christ, his sacrifice, and experience his presence as we are united as one Body of Christ.
- vii. I embrace Scripture as the unique and authoritative written Word of God. God is the primary author, working through humans, and tells the story of God's love, grace and plan for all of creation to be redeemed. The promise made to Abraham in the Old Testament is fulfilled through Jesus in the Gospels and continues to bring hope and light to all of humanity.
- viii. The church exists to provides spiritual nurture, growth and fellowship to produce disciples of Jesus Christ. The church sends disciples into the world as instruments of reconciliation to reflect God's love and mercy to all humankind.
- ix. God's sovereignty, the power of which is proven through the resurrection, is more powerful than any force, even death. The resurrection gives us life, power, and hope. Nothing in life or in death can separate us from the love of God in Christ Jesus our Lord.
- x. I believe in the life everlasting, which includes both the present and coming reality of God's coming Kingdom on Earth. I trust in God's continuing faithfulness to creation, and that whatever is to come will not contradict the creative, redemptive, and sustaining grace already revealed by the triune God.


#### **JOURNEY OF FAITH**

- I was born into a loving family of faithful Christians and raised within a supportive community of faith. One of my earliest memories is trying to memorize the Apostle's Creed as I watched my grandmother recite it on Sunday mornings with the rest of the congregation in our tiny country church, where attendance was small but love and faith were boundless. From those earliest years, I have never felt outside of God's grace.
- My journey of faith is not one of twists or dramatic U-turns. Instead, mine is a story of being drawn deeper and deeper into God's presence and the security of God's love. In the 40+ years since that earliest church memory and the present, my faith has been formed and forged through the trials of life. The continually emerging result is a resilient faith and a relentless hope.
- My call to ministry has followed a similar progression. There have been a multitude of instances and circumstances in my life where God has whispered over and over that God has a bigger plan for my life than I could ever think or imagine.
- As is God's way, people were put in my path that vocalized encouragement and poured into me. From the youth leader who first told me I was a natural communicator; to the female pastor who demonstrated that it was indeed possible to dream new dreams with God in mid-life; to my husband who, after watching me give my first children's sermon in 2012, declared to our own children, "I think Mom is going to seminary someday!" Ever faithful, God placed the right people, at the right time, so that I might see myself as God sees me.
- I've been on the path to vocational ministry for well over half my life. The internal question of whether or not I was living into the gifts and talents God had placed within me was persistent amid the ebb and flow of my life. Throughout my life, regardless of current occupation or season of life, I have tried to live into God's calling—to live my life as an act of worship and a "thank you note" back to God for the unconditional gift of unfailing grace.
- I have lived into callings as wife, mother, volunteer, and lay ministry staff leader. For the past decade, I have served Christ's church in various roles of vocational ministry, mostly centered around instilling an authentic faith in the next generation and equipping families to reflect the love of God and light of Christ in their own hearts and homes.
- At this point in my Christian journey, I am being called by the Holy Spirit to pursue ordained ministry, confident in the fact that, although *all* are called to ministry, *I am called* to use my God-given gifts and abilities to further God's kingdom as a Minister of Word and Sacrament and ordained teaching elder in the Presbyterian Church USA.
- I fully and wholeheartedly place my trust in God to be continually renewed and sustained so that I can participate in God's transforming work in our world. Not because I think it is my job to change the world on my own, but because I understand it is my honor to participate in the transformational work of God through the church.
- God has a message of hope that the world desperately needs to hear. I believe the church is uniquely positioned to bring that message to the world—to help people find and give hope. I believe I am uniquely equipped, through God's grace, to be an instrument of reconciliation and a messenger of that hope by reflecting God's love and light into our dark and hurting world.

# Summer Camp 2021 Ministry Report

What an amazing summer of camp ministry! In all, 826 campers attended our day camp or resident

camp program this year, a 93% increase over the last 3 years. We are so proud of the growth in camper numbers and so grateful to all the individuals and churches who recommend camp to their friends and communities. Most of our sessions this summer were full! In order to add more campers, we will need to build new facilities. Campers and staff enjoyed site renovations and additions like our new outdoor basketball and four-square court, new river swim location, and disc golf course.



## Peace Camp! Partner Day Camp in San

Antonio. In 2021 we partnered with Peace Camp, a day camp hosted in partnership with Emmanuel Presbyterian Church and Divine Redeemer Presbyterian Church both in San Antonio. JKR sent trained staff to San Antonio to help run the day camp for 2 weeks. Each Friday, Peace Camp loaded into cars and visited JKR for the day, singing songs, having lunch, and swimming in the Blanco River. Community members from Divine Redeemer helped feed the JKR staff while in San Antonio and 13 middle schoolers from the church communities served as volunteer "Junior Counselors". A grant from the Mission Outreach and Justice Committee of Mission Presbytery helped cover the expenses. Thank you! Together we served 46 campers! We love this ministry partnership.

**Family Camp.** We also hosted our second weekend family camp. Eight families from across the Presbytery, some affiliated with a Presbyterian Church, some not, spent a weekend playing and praying together. It was wonderful to see families reconnect with each other and share the experience with

other families. We plan to grow this program in the coming year. Our next family camp weekend will be a Winter Camp Dec 10-12th. We will hike, drink hot chocolate, go Christmas caroling, make Christmas cookies, and do a polar plunge in Blue Hole! (challenge by choice of course).

**Angel Tree.** Fifteen campers came from a new partnership with Angel Tree, an organization that serves children with an incarcerated parent.

**Supervised Practice of Ministry**. For the first time, JKR partnered with Austin Presbyterian Seminary to host a summer intensive Supervised Practice of Ministry (SPM).

- 826 campers
- 352 first time campers (43% of total campers)
- \$39,874 worth of camp scholarships awarded
- 145 campers on scholarship (18% of total campers)

Our seminary student, Katie Henderson, organized and trained our summer volunteer chaplains, served as chaplain to the summer staff, and anything else that camp needed her to do! Katie is considering a career in camp ministry and we hope that her summer JKR helps her discern God's call.



# DISASTER PREPARATION AND ASSISTANCE COMMITTEE (DPAC) REPORT TO MISSION PRESBYTERY October 2021

### MISSION PRESBYTERY DISASTER PREPAREDNESS GUIDELINES

This comprehensive document has been developed by DPAC and sent to congregations in Mission Presbytery. Congregations are encouraged to make this part of their Manual of Operations.

**FIREARMS POLICY** With input from General Council, DPAC proposes a Firearms Policy for Mission Presbytery events.

**FORD F-350 TRUCK** We have received nearly \$40,000 of the needed \$65,000 in donations for the truck that has the capability to haul shower trailers and generators to meet the disaster recovery needs in Mission Presbytery and beyond. The plan is to house the truck at John Knox Ranch for their use when not needed for disasters.

**GENERATORS TO LOUISIANA** We are grateful to Rev. Chad Lawson, pastor at Canyon Lake, for transporting the two Presbytery generators to Louisiana in response to Hurricane Ida.

**PRESBYTERIAN DISASTER ASSISTANCE TRAINERS IN MISSION PRESBYTERY** Currently we have three PDA trainers. Plans are to have a variety of disaster preparedness resources available to congregations. Ideas include virtual panel-type training and Minute for Mission videos. For more information about becoming a PDA trainer, contact one of our current trainers.

**HYGIENE KITS AND CLEAN-UP BUCKETS** All congregations are encouraged to build a supply of hygiene kits and clean-up buckets to keep in storage for future disasters.

**CHAINSAW TRAINING** We plan to offer training later this fall.

**2022 DPAC BUDGET** Our first budget has been submitted to Stewardship & Fiscal Oversight Committee. Grants will also be solicited.

**DPAC DISPLAY TABLE AT PRESBYTERY MEETINGS** As soon as we are meeting in person, we plan to have a display table at Presbytery meetings to provide information about the work of DPAC.

# Mission Presbytery, Presbyterian Church (U.S.A.) Mission Outreach and Justice Committee (MOJC), 2022 Ministry Grants Funding Guidelines October 12, 2021

- 1. MOJC has its own portion of the 2017 assigned Resettlement funds of which some of that <u>money can be</u> <u>used to provide grants funding for 2022 MOJC grant applicants.</u> Resettlement funds were portioned out to our committee (and to other Mission Presbytery Committees) as a result of the settlement agreement with First Presbyterian Church of San Antonio in 2017. Again, of which some of the remaining balance can be used to provide grants funding for 2022 MOJC grant applicants.
- 2. In addition, MOJC hopes to receive some additional monies to use for grant funding.

### Rationale

In support of mission within Mission Presbytery, we believe:

- That Jesus Christ calls the church to minister to those who are poor, hungry, despairing, oppressed or suffering from injustice.
- That sharing in mission work with others is a desirable witness to the oneness of Christ's grace, love and ministry, and that sharing in mission with those of other faiths opens new opportunities for mutual understanding and the maturing of faith.
- That it is God's will for Christians to be involved in mission not only with financial resources but also with love, mercy, compassion, and justice.

### Overview

A very limited number of annual grants may be made to any Congregation, Mission Presbytery Committee, worship community, new church development, or mission partner of Mission Presbytery. In addition, agencies and entities in which Mission Presbytery as a body maintains membership (examples: Texas Conference of Churches, Texas Impact) are also eligible for grants. Any Non-profits making a grant application that are associated with any of the above will also be considered. New initiatives may be given priority in grant evaluations. Grant applications are evaluated by the Mission Outreach and Justice Committee (MOJC). MOJC makes funding recommendations to Mission Presbytery General Council.

### **Mission Grants Application Process**

The application process serves to identify and support programs or projects (hereafter projects) worthy of the participation and support of our member congregations. These projects shall be located within the bounds of Mission Presbytery, along either side of the border with Mexico, and in other countries where Mission Presbytery or its churches have an active partnership relationship.

The Ministry Outreach and Justice Commission of Mission Presbytery employs the following criteria in considering mission projects for possible funding and support:

- 1. The project shall demonstrate the gospel of Jesus Christ in word and deed and shall be a valid response to God's will as affirmed in the *Rationale* above.
- 2. Those working in the project shall understand that Mission Presbytery considers the project to be an instrument of its ministry outreach in the love of Jesus Christ.

- 3. There shall be some participation in the project by Presbyterians living within the bounds of Mission Presbytery.
- 4. MOJC may request a site visit before funding is granted and/or during the term of a grant.
- 5. Since the Presbytery, through its outreach efforts, seeks effectiveness in the work of the Church, as well as good intentions, the Mission Outreach and Justice Committee (MOJC) will review grant applications according to these additional criteria:
- The project shall be working in an area of <u>clearly identifiable need.</u>
- The project shall exhibit competent management of its affairs.
- There shall be evidence of enthusiasm and dedication among those engaged in the work.
- Whenever possible, the project should involve persons from the community serving in the planning and execution of the project, including development of leadership and financial support.
- The project shall have specific written goals including plans for their achievement and methods for assessment of progress.
- The past record, if any, of the project shall demonstrate accomplishments related to its purposes.

Nonprofits, [other than PC(USA) affiliated churches] making a grant application must submit a copy of:

- o Annual operating budget and project budget when appropriate
- o Tax Exemption Letter from the Internal Revenue Service (IRS).
- o The most recently filed IRS Form 990 including Schedule A.
- o The most recent independent financial review or audit. The audit/review must cover a period ending no earlier than 18 months prior to the application deadline. Agencies with an annual income of \$750,000 or more must submit an audit.

For grants selected for funding, a short article (preferably with photos) and suitable for publication in Mission Presbytery Weekly news must be sent to the MOJC within 60 days from the time the grantee is notified of funding. The well –edited article should summarize in as short a way as possible the project described in the funded grants projects and also describe how the grant furthers the mission of the Presbytery. The article should be written in an engaging, clear, creative & concise manner suitable for publication on Mission Presbytery's website or for distribution in an emailed newsletter.

# Failure to provide complete documentation as stated above may result in disqualification from grants evaluation process.

Additional opportunities: Your project may be eligible for an additional grant fund being administered by Mission Presbytery called the Better Together Fund. The Better Together Funded grants are approved by the Stewardship Team, the General Council Leadership Team and the General Council. The Better Together Fund encourages more than one group to participate together, collaborate. Collaboration is not a requirement of MOJC's grant applicants; though we encourage it. Our committee's only involvement with the Better Together Fund is that we may be asked to endorse an applicant to the Fund. Our committee does not make funding decisions for Better Together Applicants. Only endorsements.

### ECN Report to Mission Presbytery 10-23-2021

In January of 2021, Mission Presbytery, gave the ECN (Education and Congregation Nurture) committee permission to take a Sabbatical year during 2021. During this year the committee was to look to the future as the process of handing oversight of the Commissioned Pastor/Certified Ruling Elder program to Committee on Preparation for Ministry, was completed.

Under the leadership of Moderator Jennifer Mitchell, ECN created a survey to assess the Christian Education and Nurture needs of Mission Presbytery. All congregations were invited to fill out the survey on the Presbytery's website.

At the ECN March 2021 meeting, the Committee began the work of discernment by going over the results of the survey that congregations in MP had filled out. We had twenty-one responses. A few things stood out from the survey:

- Most educational programs are put together and overseen by Pastors, or committees, volunteers
- There is a need for information about curriculum evaluations, etc. There seems to be a need for theological sound Bible studies.
- Concerns about how to do Christian Education for children during the pandemic
- Desire to connect with others who are doing Christian Formation throughout the Presbytery

It was also acknowledged the needs of smaller congregations with small numbers of children and youth, look different than larger congregations.

### One member of ECN shared her dream for the committee:

"The past focus of the ECN Committee seems to have been informational, educational, intellectual in nature and scope. Its work primarily engaged people's left-brain. Christian faith formation also needs to engage the right brain. It needs to speak to, to sing to, the right brain, or better yet it needs to speak to the deep heart, which comprehends the mysteries of faith and love. It is the deep heart, which ignites our hearts, our will, our purpose to live into and for the Kingdom of God here on earth."

The above statement struck a cord with the committee and guided our discussions. Looking at what the committee had done in the past and prayerfully discerning the future the ECN committee considered how the committee could serve Mission Presbytery, by supporting the faith formation needs of the congregations of Mission Presbytery.

At our June 2021, meeting we adopted not only a revised statement of purpose but also approved changing the name of ECN to Faith Formation Committee.

The purpose of the Faith Formation committee is to provide faith formation activities and tools to support and empower educators, pastors, volunteers, and congregations of Mission Presbytery.

At the September 25, 2021, General Council meeting the council approved the two motions presented by the ECN Committee:

- 1. To change the name of the Education and Congregational Nurture Committee to the Faith Formation Committee
- 2. To approve the attached handbook for the work of the Faith Formation Committee

In anticipation of GC approval the Faith Formation Committee has already begun brainstorming different ways that we can serve Mission Presbytery, by supporting those responsible for faith formation programs for their congregations, by providing workshops, by encouraging and offering help on developing spiritual practices for leaders and congregations, as well as curriculum helps. We would also like to offer scholarships to attend APCE (Association of Presbyterian Church Educators) Annual Events and the SCRAPCE (South Central Region of APCE) Fall Events.

The committee is excited about the future that God, through the Holy Spirit is leading us into.
